1. COMPETITIONS AVAILABLE: The FYSA is sanctioning Region Cup competition in each of the categories listed below:

These competitions are open to any qualified team not entered in Florida State Cup or District Cup.

Preliminary round for age bracket play is Round Robin Play (3 games) at various sites TBD.

Round of 16 and Quarter-Final round play is single elimination (based on points for seeding process). Teams will not be paired against a team if they were in their Preliminary Round play bracket. Various sites TBD.

Semi-Final/Championship Rounds - TBD

2. DATES OF COMPETITION:

Application deadline December 17, 2010 by 5:00 p.m. **MUST BE DONE ONLINE** (see section 6).

Application fee must be submitted by team by December 17, 2010, in order to be in the draw. This is a non-refundable entry fee.

Late applications will not be accepted after the deadline.

3. LACK OF COMPETITION:

If fewer than four (4) teams enter an age category, the Region Cup Committee reserves the right to determine if a competition in that category will be offered. If no competition is offered, then those teams that did enter will be given the option of entering a higher age category or the return of their entry fee.

4. GENERAL RULES OF ELIGIBILITY:

Teams, players, officials and managers will conform in this competition to all rules and regulations contained in the Constitution and Bylaws and Guidelines of the Florida Youth Soccer Association (FYSA), and as presented herein. In the event of conflict, rules herein shall have precedence.

*Acceptance of a team into this competition does not preclude the challenging of any players, coaches or teams. The roster freeze date is the final date on which all changes, additions or deletions to a team's roster must be made. Players with season ending injuries cannot be replaced once the roster is frozen. Any changes to the roster after the roster freeze date will result in the team being disqualified from the competition.

A. Team Requirements:

Each team must demonstrate continuity of rosters between their league competition and Region Cup competition.

1. Team must be properly registered to FYSA and in good standing with all dues and fees paid including Region Cup fees.
2. All players must play on their primary registered/rostered team.
3. There shall be no guest players allowed for Region Cup.
4. Roster size:
 - a. U11 & U12 teams may not have more than fourteen (14) players, a minimum of seven (7), and a continuity of five (5) rostered players.
 - b. U-13 – U15 teams may not have more than eighteen (18) players, a minimum of nine (9), and a continuity of nine (9) rostered players.
 - c. U-16 – U19 teams must not have more than twenty-two (22) players on their roster at any time during the seasonal year, a minimum of eleven (11), and a continuity of nine (9) rostered players.
5. Any player(s) and/or coach(s) that received red cards during prior and/or this season's Region Cup games cannot be removed from the game rosters, and must remain on all subsequent game rosters until their suspension(s) has been served.
6. Teams may not enter any other FYSA Cup competition during this seasonal year.
7. NO STATE CUP PLAYERS ARE ELIGIBLE TO PLAY ON REGION CUP TEAMS.
8. Acceptance of team into this competition does not, by that acceptance, confer unchallenged eligibility.
9. Each team entering must compete in an FYSA affiliated interclub league of at least four (4) teams, and have played at least three (3) games against these teams.

10. All teams must register with the division they played in during regular league play for the seasonal year. Teams will be allowed to “play up” a division, but CANNOT play down a division, i.e.:
- Division 1 and teams who played a CDL division 1 schedule in league play must play division 1 Region Cup. This does not mean all CDL teams must play division 1. If teams played in USA or CDL league play other than division 1, then they are allowed to play division 2 in Region Cup.
 - Division 2 teams are allowed to play up to division 1.
 - U16 – U19 teams consist of only one division in Region Cup.

Read applications carefully. There could be a \$500 fine if wrong division.

B. Players/Coaches Requirements/Roster Freeze:

- Players/coaches must be in good standing and have current, valid, verified USYSA permanent passes and will only be allowed to participate in any game of this competition with this pass properly signed, current picture attached and laminated. No “Florida” or temporary passes will be allowed in Region Cup competition.
- A maximum of three (3) rostered coaches may be on the players’ sideline during any Cup game. They must have a valid coach pass and be listed on the official roster.
- Double lamination or picture on picture is not allowed.
- Once the Region Cup roster is frozen, and a player has participated in a Cup game, he/she is “Cup bound” to that team and cannot play on another Region Cup team. Said player may not transfer off this Region Cup team until this team is eliminated from Region Cup/President’s Cup.

5. FEES AND FINES:

A. Fees:

Application fee must be submitted by team by December 17, 2010, in order to be in the draw. This is a non-refundable entry fee.

- U11 – U12 \$250
- U13 – U19 \$300

B. Referees and assistant referee fees for all games for the entire weekend will be paid in cash (no credit cards will be accepted). With the correct change in denominations of 1’s, 5’s and 10’s at each pre-game check-in. It is the responsibility of each team coach or manager to pay half of the total fee in exact cash.

C. Per team referee fees are **per game as follows:**

Failure to pay referee fees will result in a forfeit for non-performance and fine as outlined below. Please look at your schedule to determine how many games your team will be playing prior to check-in.

D. Non-Performance and Forfeiture Fines:

1. The following actions shall constitute non-performance and forfeit:
 - a. withdrawal from the tournament after the posted deadline date or
 - b. failure to show for a scheduled game or,
 - c. failure to pay required referee fees.
2. Teams may be fined up to \$1,100.00 for a forfeit of the tournament after the deadline.
3. A team will be fined \$100.00 for each individual game forfeited.
4. If notification of forfeit is not given seven (7) days prior to the game, and additional fine of \$300.00 will be given.
5. A team that drops after the withdrawal deadline may be required to post a bond of \$500.00 in future years. The club may also be required to post the bond in future years with a maximum of \$1,000.00 to cover all entrants.
6. Notification of a team(s) inability to play must be received IN WRITING to the Cup Chair (Vice President Region C Dave Ditillio) by January 10, 2012.
7. All forfeits will be assigned a score of 3-0 in favor of the opponent.
8. Referee fees for semi-finals and finals will be paid out of Region Cup funds.

6. ENTRY APPLICATION:

The only method of application for Region C Cup is electronically (on-line) through the FYSA website. Once completed, print out the electronic application, supply appropriate signature(s), and accompany with a club check or money order the appropriate Region Cup fees (made out to Region C Cup) and send to:

All applications will have a date and time stamp which MUST be prior to the application deadline December 18, 2011 at 5:00 p.m.

7. OPERATION OF THE CUP COMMITTEE:

The Region Cup competition will be under the jurisdiction of the Region Cup Committee. The Committee reserves the right to any final decision with regard to rule interpretation and/or to the completion of the tournament which will include, but not be limited to: drawing for grouping, selection of tournament sites, scheduling of referees, eligibility of teams or players, fines or forfeitures, selection of awards, or sponsorships and promotions.

A. The Regional Cup Committee shall consist of: Regional Vice President (Chair) and District Commissioners of Region C (please refer to page 11).

B. Tournament Format:

1. Tournament shall consist of:

Preliminary round – round robin group play (3 games)

Round of 16, quarter-finals: single elimination. Based on points of seeding process from group play.

Championship Round – single elimination. Based on seeding process.

2. GAME POINTS:

- 5 point for a win
- 2 points for a tie
- 1 point for a shut out WIN
- 0 points for a loss - forfeit recorded at 3-0 score (no shut out point)

If two teams are tied on points based on the above at the end on group play, the advancers will be determined based on the following tie breakers:

3. TIE BREAKERS:

- a. Head to head competition; if no clear winner then
- b. Net goal differential (max 3 per game); if no clear winner then
- c. Goals scored up to a maximum of three (3) goals per game then
- d. Least goals allowed: (max 3 per game) if no clear winner then
- e. Kicks from the penalty mark per FIFA rules.

If there are more than two (2) teams tied, option A will be skipped and the tie breaker starts at option B above.

8. TEAM CHECK-IN PROCEDURE:

Rosters will be provided by FYSA. The tournament shall keep team passes for the weekend. The following information is required to be presented at check-in. Coaches and/or team managers with incomplete information will not be allowed to check-in.

- A. For all rounds, a representative from each team must be at their site no less than one (1) hour prior to their first scheduled game time for check-in with the Site Director(s).
- B. The team representative shall present passes, coaches first then players in alphabetical order, for all players and coaches listed on the official FYSA roster and participating in the games. The team representative will be required to enter the jersey numbers for each player participating in the games onto the official FYSA roster provided by the tournament.
- C. Current notarized medical releases for each player shall be presented to the Site Director(s). Possession of said medical releases shall remain with the team.
- D. Referee and assistant referee fees shall be paid to the Site Director(s) at check-in for the entire weekend. These shall be the correct change in denominations of 1's, 5's and 10's (see referee fees for exact denominations on page 4). Checks, credit and/or debit cards cannot be accepted. If fees are not paid before the first match, the team will forfeit their game(s). This stands for all rounds except Championship weekend.
- E. Players are not required to be present for check-in.
- F. It shall be solely the team's responsibility to determine the status of it's players. At time of check-in, the coach/team manager must inform the site director and note on the roster any player who will not be participating in the match due to absence, injury or suspension (i.e.: for a previous red card) that is to be served, or those wearing casts. Failure to do so shall be evidence that all players on the roster did in fact participate in the match. It shall be the coach's responsibility to ensure the information has been documented on the game report. Failure may result in the player receiving an additional game sanction(s)

- G. Coaches/team managers may receive a welcome bag and any updates to the schedule at the time of check-in. It is the responsibility of each team registered and participating in Region C Cup to verify game dates, times and locations through the utilization of the official Region C Cup web site. It is the coach's responsibility to insure their team reports to the correct site and fields for their scheduled game times. This can be accomplished by checking the FYSA web site frequently. The Region Cup Committee will not be responsible for notifications beyond the posting of the original schedule on the official Region C Cup web site.
- H. The coach/team manager for all U16 – U19 teams with rosters of more than eighteen (18), the team representative must declare their 18-player game roster for each game. This can be done at check-in for all games for the weekend or must be done with the Site Director(s) at least one (1) hour prior to each match and prior to their game report being sent out to the field with the referees. Players/coaches not participating will be lined out on the official FYSA roster. Exception: any players and/or coaches not participating due to red card suspensions must remain on all subsequent game rosters until their suspension has been served.
- I. First team listed is the home team. Home team is to change jerseys if referee deems a conflict.

NO PASS – NO PLAY – NO EXCEPTIONS

9. PRE-GAME PROCEDURE:

Before games may begin:

- A. A team shall be allowed a fifteen (15) minute grace period from the scheduled game time before awarding the game to their opponent. A team "walking off" the field during the game shall be considered to have forfeited. This forfeit shall be awarded a 3-0 score. Failure to play scheduled matches will automatically require payment of the prescribed forfeiture fine (see section 5). If both teams fail to appear they shall both be charged with a loss and charged three (3) goals scored.
- B. Credentials checks shall be conducted at the field prior to each game. Referees shall verify the identity of each player against the player pass and shall check off players participating in the game on a copy of the official FYSA roster in the packet furnished by the Site Director(s). The player and coach passes, and the roster shall be given to the assistant referee for safe keeping during the game, and retained for attachment to the game report. The game report, team rosters, and player and coach passes shall be returned to the Site Director(s) immediately following each game.
- C. Only at this pre-game procedure may a player be challenged by an opposing coach/team manager. Challenged player(s) will be noted by the referee on the Referee Game Report, but will be allowed to participate in the game (if the player has a valid, verified player pass and is listed on the official FYSA roster). A challenged player does not constitute a game protest but may serve as the basis for protest should one be submitted.
- D. In no event will a referee allow a player to participate without a valid, verified player pass or without required protective equipment.
- E. In no event will a referee allow a player to participate with any type of cast or jewelry.
- F. At any time a coach/assistant and/or team manager plays an ineligible player, the team shall forfeit all matches played and be eliminated from the remainder of the Region C Cup tournament.
- G. A player who arrives at the playing field after the start of the game must first be checked in by the Site Director(s) and then may enter the game once the game official(s) verify the player is eligible and with the permission of the center referee. A late arriving player may be challenged at the time he/she is allowed to participate by the center official.
- H. No more than three (3) team staff members are allowed on the side with the team. All must have the appropriate US Youth Soccer pass and be listed on the official FYSA team roster.

10. LAWS OF THE GAME:

All games shall be in accordance with the FIFA Laws of the Game except as modified below:

LAW I – The Field of Play: The field of play may be reduced to minimum dimensions: Age Group U11/U12 will play 8 V 8 in accordance with recommendations in the FYSA Coaches' Handbook.

LAW II – The Ball: The size of the ball will be as follows:

LAW III – Number of Players: Substitution shall be unlimited. Substitutions may be made only upon notification of the referee through the assistant referee and with the referee's permission at the following times:

- A. Prior to a throw-in in your favor.
- B. Prior to a goal kick by either team.
- C. After a goal by either team.
- D. At the beginning of second half or overtime periods.
- E. At the referee's discretion:
 - 1. Attention is called to Law III (5B) – The substitute shall not enter the field until the player he is replacing has left, and then, only after receiving a signal from the referee.
 - 2. Any suspended player/coach must leave the player sideline and immediately report to the Site Director(s).

LAW IV – Player's Equipment: Players' equipment shall meet these additional requirements:

- A. All players will wear shin guards under the socks.
- B. Teams will wear uniforms of a matching design and color with unique numbers on backs. Uniforms must have a unique number.
- C. In the event of conflicting team uniform colors, the designated home team will be required to change to a color accepted by the referee.
- D. Jewelry, headbands, bandannas, braided beads, hard-billed hats or other items deemed hazardous or adornment not in the spirit of the game are prohibited.
- E. Casts and Braces: NO CASTS. Players wearing an orthopedic cast shall not be eligible to participate in any game. Soft braces may be allowed if:
 - 1. The player has a written statement from a physician stating that he/she feels the brace is necessary and that no further injury is likely to occur to the joint that is supported by the brace, and
 - 2. Judgement as to the safety of the brace is at the discretion of the referee.

Note: A player may be removed from the game if at any time the referee determines a player is using or attempting to use the brace to injure another player(s).

LAW V – Referees: Referees shall be required to complete and submit the official tournament game report to the Site Director(s) immediately following the game. The game report shall include the player's names, player pass numbers, team names and team code of all players issued red and/or yellow cards along with their player pass and details of any other matters, involving any improper or unsporting conduct of a team, its players, coaches and/or supporters.

In the event the assigned referee fails to appear, the senior assigned referee shall assume the duties and shall find an alternate assistant. The game will be played as scheduled and will be deemed official.

LAW VI – Assistant Referees: Two (2) assistant referees shall be used for all matches for U11 and up games. In the event one or both of the assigned referee assistants fail to appear, the referee must find a suitable replacement(s). The game will be played as scheduled and be deemed official.

LAW VII – Duration of the Game: The duration of the game for Preliminary Rounds will be as follows:

- A. Preliminary Rounds will not go to overtime. Ties will be applied for this round.
- B. Round of 16, Quarter-finals through Finals, all games times will resort to regulations as noted below:

*If no winner is decided in overtime, then penalty kicks will be taken in accordance with the laws of the game.

- C. Any match in which the goal differential is six (6) and once the whistle blows for the second half, the game shall be declared completed at that point.
- D. At any time in the 2nd half the goal differential reaches six (6) the match shall be declared completed.

11. CONTROL OF SIDELINE CONDUCT:

Players, reserve players, coaches, assistant coaches, team managers, spectators and fans are expected to conduct themselves with the letter and spirit of the Laws of the Game. The tournament officials shall have the authority and responsibility to remove any person(s) from the site for abuses to good conduct, in addition to any specific disciplinary actions brought about by other authority. In addition to the rules of good manners, these rules will apply to this tournament.

- A. The tournament Site Director(s) will designate one sideline to be for the sole use of players listed on the game rosters, and three (3) team officials from each team, with one team occupying one side of the midfield and one team the other. While the game is in progress, the team officials and players must remain within their respective technical areas and should remain seated on their respective benches except to give tactical instruction or to make substitutes. No continuous talking or walking the sidelines will be tolerated. The use of cell phones and/or walkie talkies from the bench area sidelines is prohibited.
- B. The Site Director(s) will designate the opposite sideline for spectators and fans.
- C. A restraining line of contrasting color from the touchline may be drawn three (3) yards from the side touchline and all sideline viewers must remain outside of that line.
- D. Team officials will be responsible for behavior of their coaches, managers, players, fans, and spectators.

- E. A registered member of the team's staff must escort any player red carded from the field of play. Said player must sit at the Site Director's tent, headquarters or designated area until the field has been cleared following the game and the team is in process of leaving the site. A player under the age of eighteen (18) may leave the site only if they are released by the Site Director(s) into the care of a parent or guardian. Player and parent/guardian may then leave the site.
- F. A suspended player may be present at subsequent matches and if so, remain on the team's bench, but shall not be in game uniform.
- G. Any coach ejected must leave the site immediately following ejection. Removal can mean from the game site or from the entire sports complex if deemed appropriate and/or necessary. At the discretion of the Site Director(s), the coach may sit at the Site Director's tent, headquarters or designated area until the field has been cleared following the game and the team is in process of leaving the site.
- H. An ejected coach shall not return to the site for subsequent matches until suspension has been served. The Site Director(s) has the discretion, upon consulting with the Disciplinary Committee, to allow the coach to serve the suspension at the Site Director's tent, headquarters or designated area. Coaches who coach more than one team will be barred from all games of other teams until the suspension is served with the original team with which the coach received his/her ejection. Failure to comply may result in the match being declared a forfeit.

12. POST-GAME PROCEDURES:

We ask as a mutual courtesy both teams respectfully congratulate each other for a game well played. The coach will be responsible for the behavior of their players, fans and spectators at all times. All spectators shall remain on the spectator sideline during the match and until such time as the coach(s) have released the players after the match. Failure to remain off the field of play until such time may result in an ejection for the coach, and possible forfeit of the match.

- A. At the completion of the match, the referee will complete the game report and any other reports as may be required and will ensure the return of these and all player and coach passes to the Site Director(s). The Site Director(s) will hold all passes throughout the weekend of play, returning them at the conclusion of that weekend's play.
- B. It is required that both teams clear the bench area and the field as soon as possible after the game, no longer than ten (10) minutes.
- C. The coach/team manager of both teams will insure the sideline area is clean and all trash be disposed of in a proper manner in containers provided. Failure to do so may result in a monetary fine against the team and/or the club.
- D. Each coach will verify their score and sign the game report on the field after each game. Scores will be posted with the Site Director(s) and on the FYSA web site.
- E. Game reports as completed by the referee are the official document of the game. It shall be the sole responsibility of the coach to verify the game results after each match. It shall be the coach's responsibility to ensure the players serving red card suspension information has been documented on the game report. Failure to do so may result in the player receiving an additional game sanction(s).
- F. Player passes are to be picked up by the coach or team representative from the Site Director(s) at the completion of each weekend. A verification of the number of passes and the signature of the team representative will be required. If passes are left at the site, the coach must arrange for pick up from the site, or to have them mailed. The respective club will be billed \$25 for shipping and handling fees.
- G. Any discrepancy not reported to the Site Director(s) by the end of the day of competition will stand as reported on the game report.

13. DISCIPLINE/PROTEST COMMITTEE:

The Discipline Committee will consist of the Regional Vice President and three (3) District Commissioners who are not from the districts that are party to the discipline under review. The Committee will review and rule on all reports of unacceptable conduct by players, coaches, team managers and spectators. All protests shall be properly submitted. Notwithstanding rulings by this Committee:

- A. ALL discipline/sanctions imposed will follow FYSA guidelines.
- B. Depending on the severity of the unacceptable conduct, the Committee will impose suspensions in accordance with FYSA Rules Section 502.

14. PROTESTS:

Protests can only be submitted by a staff listed on the official FYSA roster for a team involved in the disputed game. The Region Cup Discipline Committee will rule on all protests. For a protest to be considered, the following procedure shall be used:

- A. No protests on referee judgment or discretion calls will be accepted. No protest or appeals of game outcomes will be accepted. To challenge a player, see rule 9C.
- B. VIDEO TAPES and/or any other type of photographs are inadmissible.
- C. Written notification of intention to protest along with the protest fee must be given to the Site Director(s) within two (2) hours after completion of the match being protested.
- D. The protest fee of \$400 submitted by cash, club or cashiers check, or money order payable to Region C must accompany the protest letter. Protest fees are non-refundable. Personal checks will not be accepted.
- E. The Region C Vice President will provide verbal notification of the decision within 72 hours after the completion of the last game for the entire weekend (every site included). The protest decision will be provided by e-mail no later than 5:00 p.m. of the third (3rd) day after the applicable Region Cup weekend.
- F. ALL REGION CUP COMMITTEE DECISIONS ARE FINAL!!!

15. EXTERNAL CONDITIONS, WEATHER, ETC.:

In the event unusual conditions necessitate rescheduling, curtailment, shortening or cancellation of games, the Region Cup Committee shall have absolute authority to make these changes to best serve the interest of the tournament as a whole, keeping in mind the need to successfully identify winners by a certain time period.

- A. Unfinished games will be replayed provided neither team is at fault and the second half of play had not begun. If first half had been completed and the game cannot be resumed or completed, the Committee will, within a reasonable amount of time, deem the game complete.
- B. Round Robin play can be determined finished if two (2) games have been called COMPLETE.
- C. The FYSA Region C Cup Committee and/or FYSA will not be responsible for any expenses incurred by any team due to the cancellation in part or in whole of this tournament or for any travel incidental to the competition.

16. AWARDS CEREMONIES SEMI-FINAL PLAY:

- A. For teams NOT moving to the finals, each player will receive a “SEMI FINALS” award.
- B. FINALS/CHAMPIONSHIP: Following the completion of each championship game, the two (2) teams will present themselves to the awards area where:
 - 1. Each runner-up player will receive an award/trophy, and each runner-up team will receive a trophy to keep.
 - 2. Each championship player will receive an award/trophy and each championship team will receive a trophy to keep.

17. PRESIDENT’S CUP:

The President’s Cup is the state wide tournament for all Region Cup Division 1 winners. Penalties for not attending are as follows:

- A. Failure to fulfill obligation to compete in President’s Cup event after winning Region Cup Division 1 competition, and Region unable to fill slot with another qualified team from the Region - \$2,500 fine.
- B. Failure to show for a scheduled match with no or less than a one (1) week notification - \$1,500 fine.
- C. All other matters not covered above, maximum \$1,500 fine.
