Referee
Presentation

FYSA is now using Got Soccer for referee background checks, and has created Got Soccer accounts for all FSR certified referees and Assignors. Emails have gone out to all referees certified for 2011, with log in information. Many referees have not responded to these emails.

In order for any referee to officiate any FYSA game in any capacity, they must have a current year's USSF certification, and an FYSA approved risk management status. This is done via the referee Got Soccer account created by FYSA. Referees and assignors are not to create Got Soccer accounts; they are to use the FYSA created accounts.

FYSA sends notification to all referees and assignors when notified by FSR of current certification. See example below.

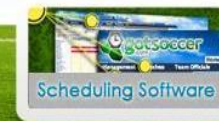

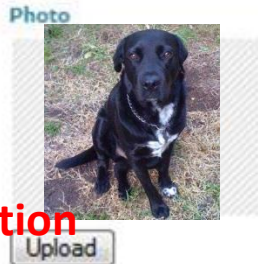
