# Affiliate Responsibilities

- One person is designated as Agent Of Record (Master account holder).
- Club's may have up to 2 agents.
- These must be listed in the club 'User Accounts' page.
- Affiliates are responsible for registering these persons with FYSA as coaches and verifying that they have an approved RM (Risk Management) status.

The next screen shows where you would create the User Accounts for access to Got Soccer. Only one person (must be a persons' name) is Agent of Record (Master Login).

The affiliates may have an additional 2 agents.


The number of User Accounts has no limit.

If an affiliate member has multiple roles, that person must have multiple accounts. An account for each role is required

# Agent of Record

- **is the only person** who can submit the annual affiliation form for the affiliate.
- **is the only person** who can sign a proxy for FYSA business.
- **is the primary contact person** for FYSA official business.
- **must be listed by name** as the Master Account (Master Login) holder.
- **Passes title to new Agent of Record** by giving new AOR username and password.
- **Authorizes** all affiliates user accounts

# Agent & Agent of Record

- **May** collect credentials at the AGM without a proxy from the agent of record .
- **May** conduct business with FYSA.

## The Agent

- **May** petition FYSA to replace the Agent of Record if the Agent of Record has died, moved away etc.

# Credentials

- Agent of Record and Agents may be updated at any time by the affiliate.
- Last day to update Agent of Record or Agents names for the 2011 AGM is July 15
