Guest Speaker: Guy King and Tammy Marshall--FYSA Insurance

 Discussion and break down of 2019-2020 insurance rate and increases which occurred to help the board understand the largest increase in rates we have seen. Big increases due to 2 specific claims and increased excess GL coverage from \$1 million to an additional \$5 million for a total of \$6 million in coverage for the state organization mandated by USYouth Soccer. Per player rate increased from \$4.21 in 2018-19 season to \$6.85 for 2019-20 season.
