### **Business**

 Discussion on New 11u and 12u FSPL Futures League and FSCL Florida State Competitive League

Jill Hartley, FYSA Director of Competitions was given the opportunity to explain the new programs which were just announced to the membership for the upcoming season including FSPL Futures 11u & 12u programming and the new FSCL Florida State Competive League. BOD was given the opportunity to ask questions of Jill to better understand the reasoning and justification for the new leagues and questions were asked of Jill to clarify and improve understanding of how the leagues will be set up and operate including how the leagues will be regional within areas of the state including North, Central and Southern Zones. Questions were also asked regarding the size of the leagues, how this would impact or interfere with affiliate leagues, and how and why did we decide to create the u11 and u12 FSPL Futures programming. Jill answered all questions.

The BOD directed that the Staff create a FAQ page to answer questions regarding the two leagues.

BOD had further discussion on the leagues and Shenoy Raghuraj, FYSA VP Competition recognized and addressed the boards major concern about communication of the programs. He recognized that the announcement of the new leagues prior to the proper dissemination of the new league programming to the BOD was not executed in an effective manner and committed to making sure that future plans would be more transparent and effectively communicated prior to announcements being made public.
